Tree' by Tony Orlando and Dawn, spent a month at the top of the UK Charts.

The UK Prime Minister was Edward Heath, a pint of milk cost just 6p and a gallon of petrol cost 39p. The average house

price in the UK was a mere £9,900.

Returning to those early days, Rory says that after getting his first practising certificate in June 1973, he quickly set up his own legal firm.

A month later - in July

1973 – his first office officially opened its doors at 76 Hill Street, Newry.

A couple of years later, in April 1977, Rory moved his young business to 34 Hill Street in Newry, where its HQ remains today, along with an office in Kilkeel.

Reflecting on how far the business has come. Rory pinpoints relationshipbuilding with clients as a critical ingredient to the firm's success.

"We focus on the needs of each client and give that client 100% attention," he explains.

"Our success in this regard is demonstrated by the repeat business we get from clients and their familiae

"McShanes has become a generational firm, parents, children and grandchildren," he adds.

"When the practice began, the office staff were using typewriters," he remembers.

"The photocopying ma chines were totally inadequate compared to what is available today," Rory insists.

And it's this ability to adapt that has helped the local law firm to continue to thrive.

"We moved from typewriters to computers, and as the technology moved forward, McShanes moved with the times and have

But technology developments weren't without difficulties: cybersecurity and data protection remain the top priority.

"Email is vulnerable. and ironically fax machines have now come back into vogue," Rory says.
